I AGREE in consideration for my participation in this Competition (Windcrest Farm) to the following:

I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware of and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury, including broken bones, head injuries, trauma, pain, suffering, or death ("Harm")

I AGREE to release Windcrest Farm, the Competition, the CHJA, *NEHC*, *CHSA* and *M&S League* from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the of the Competition.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) *Windcrest Farm* and the *Competition* and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for and Harm caused by me or my horse at the Competition. I have read the rules about protective equipment, and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that *Windcrest Farm* strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries. If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to assume the entire obligation of this Release on the child's behalf.
