I am fully aware of and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury, including broken bones, head injuries, trauma, pain, suffering, or death ("Harm")  I AGREE to release Windcrest Farm, the Competition, the CHJA, NEHC, CHSA, MHJ and M&S League from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the of the Competition.
